## EVALUATION PROCESS

The evaluation process will consist of two steps. Short abstracts of approximately 1 page can be submitted by March 4<sup>th</sup>. The submissions will be previewed until middle of March. Selected speakers will then be asked to submit an extended abstract of approximately 4 pages by April 14<sup>th</sup>. After a second review process the programme committee will compose the final conference programme out of these submissions.

## INSTRUCTIONS FOR SUBMISSIONS

Presentations at ISSE conferences are invited as well as selected from abstracts submitted in advance. The process is completely neutral: speakers are solely selected on the merit of their submissions.

- Please submit short speaker bio and full contact details of speaker in addition to your abstract.
- Please indicate topic area of the presentation.
- Please indicate the level of your presentation (basic, intermediate, technical, advanced technical) as well as the target group you want to address (legal audience, technical audience, business audience).
- Please note that only electronic submissions will be accepted.
- Subject line of email MUST contain speaker's name.
- Content of proposed presentation is much more important than affiliation or job title of speaker
